ORDERED that defendant William A. Hazel, Inc.'s Motion for Summary Judgment [Docket #65] be and is GRANTED.

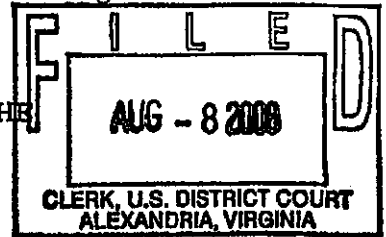
